Regular Board Meeting Minutes

Friday, July 14, 2023 | 7:30 a.m. | Forum Room, RP School

Bills: The contract with the Chamber totaled \$117.50 for the quarter ending June 30. Tesch paid for the Bluff Land Tri medals through Crown Awards for \$575.52 and needs to be reimbursed. Motion to pay these bills by Woxland, seconded by Snyder. Motion carried.

Contract with the Chamber: The contract with the Rushford Peterson Valley Chamber ended June 30, 2023, since Hengel is leaving as the coordinator and the Chamber Board no longer wants the contract added to the coordinator position's duties. Hengel would like to continue as the financial bookkeeper for the Foundation. The Board will consider how she may be compensated for keeping track of the Foundation finances, and further discussion will take place at the next meeting.

Bluff Land Trojan Kids Challenge: Tesch gave an update for the Saturday, July 15 event. Plans are coming together nicely, and volunteers that would like to help should be at Creekside Park anytime from 11-2. The kids will have practice time starting at 12:00 and the race officially starts at 1:30. The age groups are 3, 4, 5, 6, 7, 8, 9, 10.

Bluff Land Tri: There are 91 entries as of July 13th for the Bluff Land Tri on Saturday, August 19, 2023, and so far registrations total \$4,750. Tesch also brought two different BLT logo designs for the Board to consider. The committee would like a new logo since the current logo has an outdated digital file and next year is the 10th anniversary of the BLT. A new logo would be used for all future communications.

Board Members: Members whose terms are expiring October 31, 2023—Vitse, Agrimson, Culhane—are in the process of finding replacements. Former members that have served on the board are eligible to serve again after they have been off for one year.

There will be no Board meeting in August. The next meeting is Friday, September 8 at 7:30 a.m. in the Forum Room.

Motion to adjourn by Tesch, seconded by Snyder. Motion carried. The Board adjourned at 8:04 a.m.
